The Fond du Lac County fair, along with the Fond du Lac County Agricultural Society, will be hosting the 2nd annual Fondy Fair 5K Run/Walk on July 23, 2011 at 8:00am. The cost of the run will cover a run/walk shirt and admission to the fair on July 23, 2011. The Fondy Fair 5K Run/Walk is a family event and prizes will be awarded for the first place runner in each division. There will be a special division for 4-H and FFA members. The run/walk will start and finish on the fairgrounds.

2011 FONDY FAIR 5K RACE DAY SCHEDULE

SATURDAY, JULY 23, 2011 - 8:00AM - ARRIVE EARLY

Race packet pickup and late registration will be set up in an area near the fair office on the Fond du Lac County Fairgrounds between 6:45-7:30am on race day. PLEASE ENTER THE GROUNDS THROUGH THE 17TH STREET GATE.

REGISTRATION & FEES

Advanced registration is strongly recommended. Race Day/Late Registration will be accepted in the Soundstage Tent the morning of the race. Race day registrations WILL NOT be guaranteed a race shirt. NO EXCEPTIONS! The race will start and finish on the Fond du Lac County Fairgrounds. ABSOLUTELY NO PETS ARE ALLOWED ON THE FAIRGROUNDS.

FINISH Digital clock and chronomix timer at finish. All runners and walkers will start and finish near the fair office.

ALL PARTICIPANTS IN THE FONDY FAIR 5K RUN/WALK, EVENTS AND ROAD RACES OF OTHER DISTANCES CONDUCTED BY THE FOND DU LAC COUNTY AND THEIR RELATED EVENTS ("EVENT") ARE REQUIRED TO, AND HEREBY DO, ASSUME ALL RISK OF PARTICIPATION IN THE EVENT BY SIGNING THIS GENERAL RELEASE AGREEMENT: The undersigned athlete ("Athlete") on behalf of himself/herself and on behalf of Athlete's personal representatives, assigns, heirs, executors, and successors hereby fully and forever releases, waives, discharges and covenants not to sue the Fond du Lac County Fair, the Fond du Lac County Ag Society, and its affiliated companies and charities, the host city(ies), county and state, any and all municipal agencies whose property and/or personnel are used or in any way assist, all sponsoring or co-sponsoring companies or individuals related to the Event, together with their officers, directors, shareholders, successors and assigns, (collectively "Releases") from all liability to the Athlete and his/her personal representatives, assigns, heirs, executors, and successors for any and all loss(es), damage(s) and any and all claims or demands therefore, on account of injury to Athlete, his/her property or resultant death, whether caused by the active or passive negligence of all or any of the Releases or otherwise, in connection with Athlete's participation in the Event. Athlete represents and warrants that he/she is in good physical condition and is able to safely participate in the Event. Athlete is fully aware of the risks and hazards inherent in participating in the Event and hereby elects to voluntarily participate, knowing the risks associated with the Event. Athlete hereby assumes all risks of loss(es), damage(s), or injury(ies) that may be sustained by him/her while participating in the Event. Athlete agrees to the use of his/her name and photograph in broadcasts, newspapers, brochures and other media without compensation. Athlete acknowledges that the entry fee paid is non-refundable and non-transferable. Athlete acknowledges and agrees that the Fond du Lac County Fair and the Fond du Lac County Ag Society, in its sole discretion, may delay or cancel the Event if it believes the conditions on the race day are unsafe. In the event the Event is delayed or canceled for any reason, including but not limited to: fire, threatened or actual strike, labor difficulty, work stoppage, insurrection, war, public disaster, flood, unavoidable casualty, acts of God or the elements (including without limitation, rain, hail, hurricane, tornado, earthquake), or any other cause beyond the control of the Fond du Lac County Fair and the Fond du Lac County Ag Society there shall be no refund of the entry fee or any other costs of Athlete in connection with the Event. The Athlete hereby grants to medical director of the Event, and his/her agents, affiliates and designees, access to all medical records (and physicians) as needed and authorizes medical treatment as needed. Athlete understands that they have the right to refuse medical care and advice of Event medical directors and representatives; if Athlete's medical condition becomes such that the Athlete's mental capacity is questioned, the physician has the right to recommend and initiate treatment of Athlete. It is understood and agreed that Athlete hereby assumes liability for any and all medical expenses incurred as a result of training for and/or participation in the Event, including but not limited to ambulance transport, hospital stays, physician and pharmaceutical goods and services. Athlete warrants that all statements made herein are true and correct and understands that Releases have relied on them in allowing Athlete to participate in the Event. ATHLETE HAS READ THE FOREGOING AND INTENTIONALLY AND VOLUNTARILY SIGNS THIS RELEASE AND WAIVER OF LIABILITY AGREEMENT. IF ATHLETE IS UNDER AGE 18 HIS/HER PARENT OR GUARDIAN MUST SIGN THIS RELEASE AND WAIVER AGREEMENT.
